

2024 Primary is August 6

Signs are going up. Candidate events are being scheduled. It is Primary election season!


- Polling locations will be open Tuesday, August 6 at 7:00 AM.
- Absentee voting is available at the county clerk's office beginning on June 25.
- Early, no excuse voting is available at the county clerk's office beginning July 23.

The national Trump Campaign and the RNC (Republican National Committee, who we can now respect due to recent upgrades) are advising that early voting is desirable. Do not be afraid to go in and cast your vote early.

Office holders in Camden County are typically chosen during the Republican Primary. I have not seen anything about Democrat challengers so far. The Sheriff's race will not be decided until November 5 because there is a candidate from the Constitutional Party. Pretty good strategy to avoid the crowded primary I suppose. However, avoiding the vetting process by the Republican Central Committee makes any candidate a no-go from the Watchdawg Report's perspective.

Candidate vetting includes a background check, social media review, pass/fail evaluation on a Republican Values Survey, and requires a signature on the Pledge to govern per the Republican Platform.

Camden County Voters

The next Watchdawg Report in July will contain the Voter's Guide for the August 6 primary election. If you have time to research candidates, that is awesome. If you do not, the voter guide will help you sort out the best candidates.

There is one set of elections we will dig deeper into this month. The Camden County Central Committees seem to be under the radar for most voters. Let's drag all that into the sunshine and see what we see.

The two parties, Democrat and Republican, have well attended committees here in Camden County. Each Township has two representatives that attend monthly committee meetings, work on fund raising and support their party's candidates. They interview candidates to recommend replacements to the governor when a political office is vacated, according to the party holding the office. Historically, this has been a task for the Camden County Republican Central Committee.

The Central Committees are the party leadership here in Camden County. They interface with the Missouri State Democrat and GOP committees, and from there to the DNC (Democrat National Committee) and RNC (Republican National Committee). Because I have represented Adair Township on the Camden County Republican Central Committee for the past two years, I know they work hard with like-minded leadership in other counties to be a Conservative influence on the MO State GOP. As with the General Assembly, there's work to be done in the Missouri GOP to replace arrogant and foolish establishment state leadership with more energetic, forward thinking Patriots.
