The legislators set up web sites that discourage group involvement and allow a note from only one constituent at a time. We are breaking through that model to email them directly, and Bcc (blind carbon copy, aka FYI) a large group of constituents. Member email addresses are never shared. We show strength by mentioning in the emails the number of constituents that are blind copied.

Sheriff's race – 2024 November ballot

On the November 5, 2024, ballot, Camden County voters will have two choices for County Sheriff, as confirmed by the Camden County Clerk's office.

Chris Edgar is a Republican, and Patrick Cochran is an Independent with The Constitution Party. Both men are known in the community and are expected to run clean campaigns.

America First Conservatives in Camden County (AFC-CC) and The Watchdawg report hereby gives notice that pernicious attacks by any candidate, either individually or via a surrogate will be called out and we will come out in support of the other candidate. Candidates, please control your fans and let's do this without hatefulness for a change. We believe this represents the view of most Camden County voters and appreciate the positive position of the majority.

I did some research on The Constitution Party. I discovered that it was and is aligned with the Conservative Caucus which I associate with William Buckley. While not on board with all views, I remain a huge fan of Mr. Buckley and regard him as a leader in the Conservative movement. With America First and MAGA ascendant, the Republican Party has moved to the right to become a closer match to the platform of The Constitution Party than in years past. America First voters are intertwined with Conservative views regardless of party association.

There is a scenario now with the Missouri General Assembly where devoted influencers run themselves ragged during the session trying to get Office Holders who present themselves as Conservatives to vote Conservatively. Their efforts are often unsuccessful as lobbyists and corruption prevail on many votes. It is time for all of us to do our part to influence Office Holders to act on the wishes of their constituency. AFC-CC intends to connect the election season with the legislative season and job performance at all levels of government.

It is a challenge to establish this interface with elected office holders, and a challenge to track voting records and job performance which will help us know if/when to replace them. We feel that until this relationship is accomplished, corruption and lobbyists will continue to interfere with our rights and freedoms. Hopefully, valid info that is carefully acquired will carry more weight than angry Social Media rants.

Politicians at all levels do not like it when voters ask them about their work. It seems once elected, their disdain for their constituency reveals itself over time. In our travels around Camden County this election season, we have not found any rural Camden County voters who believe the promise from two years ago to improve roads has been met. While we work communications with State and National Office Holders, Camden County Office Holders will also be in focus. For example, what is the status on the \$30,000 approved for the Fair Grounds? Was that feasibility study ever completed and the money spent? \$80,000 was spent to secure the Bollinger Creek bank that is washing away White's Cemetery. Has anyone followed up to check the effectiveness of the solution applied? It appears possible that families may continue to see graves washed away, and now the county owns the fix because they made the decision to get involved in the first place. These are not inflammatory questions, and they deserve respectful answers. We'll let you know what we find out.

A local Democrat recently appointed to the Library Board wrote an opinion piece in the newspaper denigrating Republican VP Candidate J.D. Vance. I respect her right to free speech and recognize her personal victory in that she convinced the Commissioners to give her an appointment to the Library Board. So now the struggle over pornographic books in the children's section is renewed. It remains a mystery why Conservative Commissioners elected by Conservative voters would give a Liberal Democrat a position on the Library Board.
