President-Elect Trump has articulated these first ten actions:

- 1) Re-issue his 2020 executive order restoring to the president the authority to remove rogue bureaucrats, with a promise to wield that power very aggressively.
- 2) Clean out all corrupt actors in our national security and intelligence apparatus. Departments and Agencies that have been weaponized will be completely over-hauled.
- 3) Reform the FISA court system to correct the process where FISA judges knowingly or unknowingly approve requests they know are wrongfully brought.
- 4) Expose hoaxes and abuses of power that have been tearing our country apart by establishing a Truth and Reconciliation Commission to declassify and publish all documents on deep state spying, censorship and corruption.
- 5) Launch a major crack down on government leakers who collude with the fake news to deliberately weave false narratives and subvert our government and democracy. Criminal charges may be considered.
- 6) Separate IG departments from the departments they oversee. Eliminate protection of the agencies by the IGs.
- 7) Ask Congress for an independent auditing system to continually monitor our intelligence agencies to ensure they are not spying on our citizens or running disinformation campaigns against the American people. This includes spying on campaigns, as they did on his.
- 8) Continue the effort to move the federal bureaucracy out of the Washington swamp. Similar to when the Bureau of Land Management was moved to Colorado during the first term. Staff will consist of patriots across the country, as opposed to D.C. bureaucrats.
- 9) Ban government bureaucrats from later taking jobs with the companies they regulate while employed by the federal government.
- 10) Ask for a Constitutional Amendment to impose term limits on members of Congress.

We are happy to note that #4's Truth and Reconciliation Commission is declassifying documents to share with We the People...as opposed to the last administration who set up a Commission to censor social media and conservative influencers.

We need to let our legislators know to warn the Administration against a term limit bill that does not also ban lobbying. We made that mistake in Missouri where new, inexperienced legislators are left to the mercy of the more knowledgeable lobbyists to get work done. I look forward to the day when the Missouri General Assembly is more MAGA, less RINO, and good work like upgrading the statute to ban lobbyists can be accomplished.

Commissioner James Gohagan was contacted requesting follow up on the feasibility study the Commission funded with \$40K earlier this year regarding a possible Camden County Fairground. The non-profit driving the research is CCAYEC – Camden County Ag & Youth Enrichment Council. Commissioner Gohagan immediately provided a copy of the feasibility study. Thank you!

The study seems very complete, and money well spent in our opinion. CCAYEC, with the help of State Senator Mike Bernskoetter, has also secured state funding for the project. They are moving forward in Phase 1, working to procure a property of 60+ acres that will be a space for the Camden County Fair, as well as draw additional income as a rental for other events. Missouri Election Results for State Constitutional Amendments

Passed –

Amendment 2 that legalizes sports betting passed by 4,366 votes

Amendment 3 that legalizes abortion on demand passed by 95,012 votes

Amendment 7 that prohibits ranked choice voting and noncitizen voting passed by 1,037,929 votes

Proposition A that raises the minimum wage and requires paid sick leave passed by 441,339 votes

Rejected –

Amendment 5 that authorized a casino near the Lake of the Ozarks was rejected by 140,062 votes

Amendment 6 that authorized adding court fees to fund law enforcement retirement benefits was rejected by 294,943 votes

AFC-CC Update

It is important to remain fully engaged to power forward as part of the solution. Communication with our legislators is very important. How can the employees know what is expected from the boss if we do not tell them? Do you agree that many of us struggle to find the time to craft the communications necessary to stay fully engaged? America First Conservatives in Camden County (AFC-CC) membership is the free, time efficient way to have your views pressed upon our legislators. We craft letters to our legislators (e.g., Rep. Mark Alford, Senators Hawley and Schmitt, State Senator Mike Bernskoetter), then forward them to our members for feedback and approval. We then forward the final version to the legislator with all members Bcc'd. No names or email addresses are ever shared. We simply mention in the email the size of our group (294 right now) with expectation that our size will bring attention to our words. We forward their reply to the members, and together (via email) decide next steps.

Currently, we are awaiting a response from Rep. Mark Alford regarding questions about what action he is willing to take to engage on removing funding from NGO's acting against the United States while being taxpayer funded in the DOD budget in the large Omnibus bills. We are looking for full engagement from him as opposed to the 10,000 foot view he appears to take on all issues.

On November 8, we sent emails to Senators Hawley and Schmitt asking them to support Rick Scott for Senate Majority Leader. We challenged Senator Hawley regarding what appears to be his support for John Cornyn. If true, this is certainly a game changer regarding support for Hawley as a future presidential or vice-presidential candidate. We hope he recognizes his mistake and corrects course.

The only way to be fully engaged and aware of our activities and communications is to become a member of AFC-CC. With your free membership, The Watchdawg Report comes monthly via email, and we all participate in formulating the legislator emails and actions via email.

The young man that ultimately gave me the email address refused to give me his last name. The bigger we are, the more powerful we are. It is time for voters to be more influential than donors.
